Concept: this test is intended to determinate the overall migration and specific migration in food water-based simulants of plastic materials intended to come into contact with food, by total immersion of the samples at selected temperatures and times.

Testing conditions:

Simulants:

- Simulant B: Acetic Acid 3%
- Simulant D1: Ethanol 50%
- Simulant D2: Vegetal oil

Testing conditions:

- 30 minutes at 40°C
- Simulant contact by immersion

The material complies correctly with the Regulation, regarding the overall migration of the components and the simulants B, D1 and D2 so we can determine that they may stand in direct contact with all kind of foods.
